LandTrust Signs Alcoa Relicensing Settlement Agreement

Nearly 6,000 acres are proposed to be protected, which includes a 1,085 acre addition to Morrow Mountain State Park, 4,062 acres added to Wildlife Resources Commission Gamelands Program, and 750 more acres to become county public recreation areas. Teague-Smith Easement a True Family Affair

All conservation easement donations are family decisions, but when Mary Teague and her brother, Willard Smith, decided to donate an easement on their 82-acre family farm in Davidson County, the donation became a true family affair. That's because Mary and husband, James, had already deeded their share of ownership to their two daughters for estate planning purposes, retaining a life estate on the property where they will settle after refurbishing a historic home. Including spouses, eight people signed the easement, a new LandTrust record. But the effort was worth it, creating a new foothold for conservation in this still-rural section of eastern Davidson County.

Letter From The Executive Director

Saving Working Landscapes, Saving Jobs

Chris Hoffner is giving it his best shot.

A fourth generation dairy farmer in western Rowan County, Chris is doing everything he can to keep the farm operation, as well as his livelihood, going. His story was recently told in the *Salisbury Post* as part of a series on the declining dairy business in our region. With the costs of gas and feed increasing while market prices for milk remain relatively flat, Chris knew he couldn't continue to compete with those who are milking thousands of head of cattle three times per day with campuses of migrant labor on cheaper land in the Midwest and elsewhere in the South.

So Chris decided to go organic, where demand is increasing and the final product sells for a premium. But the road is not going to be an easy one. First of all, his family's 300 acres of crop fields must be converted to organic (no pesticides, artificial fertilizers, etc.) for several growing cycles before he can get "organic" certification and sell his milk for a premium. It will also take time for him to replace his herd to one completely free of the antibiotics and hormones traditionally used to create artificially long and productive lactation cycles among the cattle. During this time of increasing costs and lower output, he will still only be able to sell the milk he produces at the lower non-organic rates.

But while you and I are still sleeping each day, Chris is in the milking barn doing all he can to keep his dream of farming alive.

And his hard work is paying off. Already, he has attained certification for some of his cattle and is seeing the potential of higher returns when his entire herd becomes certified.

So what does this have to do with The LandTrust for Central North Carolina? As noted in the *Salisbury Post* story, Chris could not have had the chance to go organic if we had not contracted with the City of Kannapolis to buy their land next to the Hoffner farm and keep it in farming. Aside from preventing incompatible uses going in next to the dairy, this project also provides Chris and his family the assurance that they will continue to be able to lease a couple hundred acres for production of natu-

ral hay to feed the cattle.

Chris is working hard to keep the farm together, and his story is unfortunately not unique. We know of dozens of such similar success stories here at The LandTrust, and wish we could share each and every one of them with you, our donors and friends. Our hard work is indeed making a difference; one farm, one community, one watershed at a time. And we could not do these projects without the support of YOU, The LandTrust donor. On behalf of Chris and countless other farmers, hikers, hunters, paddlers, birdwatchers, historians, and future generations, I thank you for making these projects possible.

Teague-Smith Property Continued....



The property features rolling pasture, mature hardwood forests, about five acres of wetlands, scenic viewshed on Old Highway 64 and Conrad Hill Mine Road, and approximately 4,600 linear feet of tributaries to the nearby Fourmile Branch, which feeds into High Rock Lake. There's even a family connection to the creek. "This land originally belonged to our ancestor Captain Peter Hedrick, an officer in the Revolutionary War," says Willard. "The story is that he was

such an outstanding officer that, in return for his service during the war, he was granted land four miles down the creek and four miles across." Thus, the name "Fourmile Branch."

Today, the property's historic significance is defined primarily by the Victorian house that Mary and Willard's grandfather, Grover "Pops" Hedrick, built beginning in 1908. Mary and James are restoring the grand two-story structure, visible from Old Highway 64, where Mary and Willard spent so many happy hours. "As children we were always at that house, either gardening or playing in the attic. Now I'm going home," says Mary of her restoration efforts. "I like to call the house 'My Tara,'" she adds with a laugh.

The property is also home to an abundance of wildlife—a recent visit revealed numerous deer tracks, while a chorus of frogs sang happily from

the wetlands. There's even a ghost! "Some folks used to say you could see either a headless horse, or a horse with a headless rider, walking through the fields," recalls Willard.

Mary and Willard are proud of their efforts to conserve the family property and are advocates for conservation, reaching out to neighbors and relatives with adjoining properties to educate them about conservation options. "My family has always said, 'Save the land. Keep the land, they don't make it anymore. Be good stewards of the land,'" says Mary, explaining their decision to donate the easement. "This was the best way to do it. My mother always wanted us to protect the land, and Pops (her grandfather) would be proud we did. So we just decided to go for it." A family affair, indeed.

Thanks and Best Wishes to Kevin Redding!

In the middle of March, Kevin announced to The LandTrust he would be leaving us to assume the role of Executive Director at our sister organization to the north, The Piedmont Lands Conservancy (PLC). We would like to express our sincerest gratitude to Kevin for six years of dedication and accomplishments while working here. He has made great strides for conservation in this area, and will continue to with PLC, one of the most respected and effective land trusts in the state. This move allows him to be closer home and spend more time with wife, Lori, and son, Boone. The staff will greatly miss his positive and outgoing personality, sense of humor, and ability to make big things happen, but we

certainly wish him the best as he moves to this next stage of his life.

Kevin began with The LandTrust in 2001 as Grant's Creek Coordinator, then became the Uwharrie Land Specialist, and lastly the Associate Director. His knowledgeable experience in land conservation, along with his natural ability to work with people and strong administrative skills have helped The LandTrust make great strides for conservation.

One of his most notable achievements is spearheading the Bingham Lands acquisition, 1160 acres of mature hardwood forests with miles of Uwharrie River frontage. He has also worked to protect properties along important waterways, was an integral part of the historical Pisgah Covered Bridge preservation, and arranged for



the last-minute protection of 290 acres of would-be subdivision next to the Birkhead Wilderness Area. From protecting vast expanses of Stanly County farmland, to important ecological corridors, to reconnecting portions of the Uwharrie Trail, Kevin has provided leadership for many conservation achievements. We hope you will join us in wishing him the very best in all his future endeavors.

LandTrust Benefits from Uwharrie Trail Run

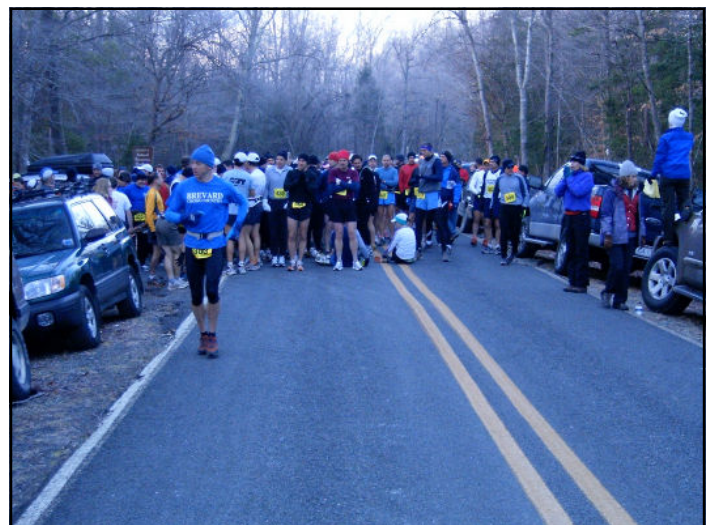
On a crisp Saturday morning in February, over 600 amazing athletes converged on the Uwharrie National Recreational Trail to challenge their bodies and minds. This year marked the 16th Annual Uwharrie Trail Run and the first time that the proceeds of the race were donated to The LandTrust to support our work on reconnecting the historic Uwharrie Trail.

These funds were used to purchase actual carbon credits on the open market and will help The LandTrust plant trees on our protected properties.

Hazen Farm, Davie County

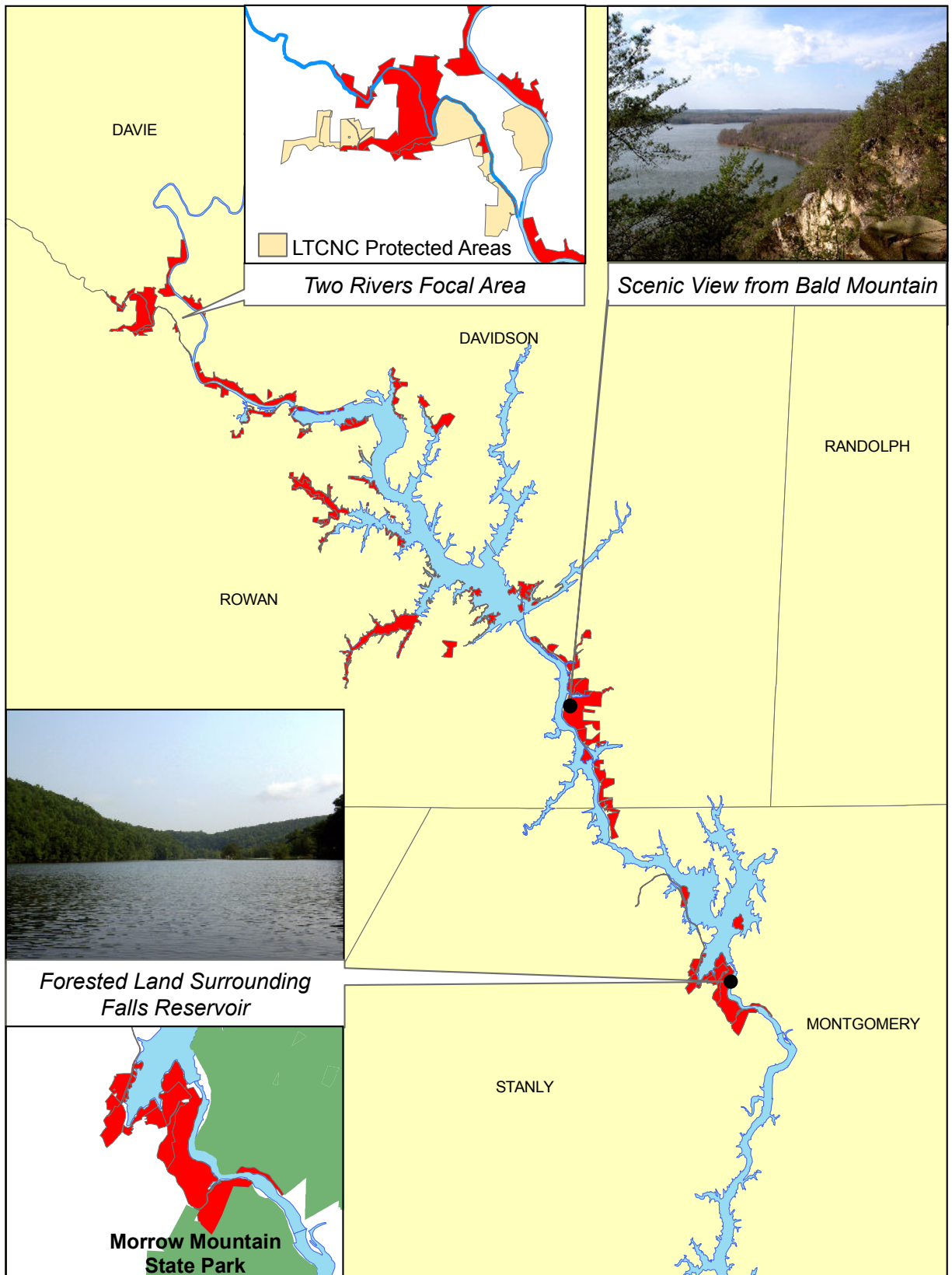

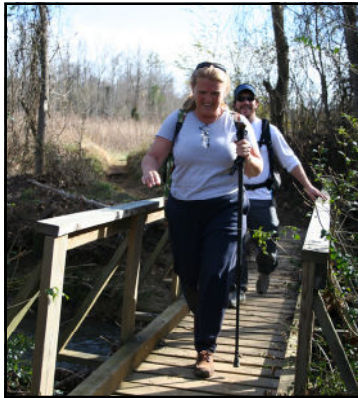
