market or market value for the easements in the hands of the LandTrust and the easements in fact impose a financial burden on the Organization. Easement donors, while helping the LandTrust satisfy conservation objectives, actually impose financial responsibilities on the Organization through their ongoing monitoring requirements. Therefore, easements acquired by the LandTrust (whether purchased or donated) are accounted as "zero value" assets and are, therefore, not reflected in the Organization's financial statements.
